

# 2010 Turfgrass Selection and Identification Workshop

## Presented by the UMass Extension Turf Program

The ultimate performance of a stand of turf depends on matching turfgrass species and varieties with site characteristics, intended use and maintenance level, and knowing what you have is the key to knowing how to manage it. In this hands-on workshop, participants will learn to identify and recognize the principal cool season turfgrasses and how to select cultivars for specific characteristics such as disease resistance, drought tolerance, wear tolerance, and vigor.
